Additional Trial Information

Class Transfers (Move-Ups) Are Allowed to the Next Level for dogs completing a title after close of entries. The request must be made IN WRITING (or email) to the Trial Secretary at least 30 minutes prior to all judging.

Bitches in Season Are Not Permitted to Compete. If a female is withdrawn from competition for coming into season and the Trial Secretary is notified no later than ½ hour prior to the start of the first class, then the club will refund the entry fee. **A processing fee of \$8.00 per entry will be retained.** A signed veterinarian's letter stating the bitch is in season may be required.

Food – Food will be available for purchase on the grounds from Bulldoggies of Humboldt. They will be serving breakfast and lunch, plus coffee and other beverages, with a nice variety of food items from which to choose.

Directions from Redwood Acres to Veterinarian:

1. Head east on Harris St toward Hall Ave.
2. Turn right onto Myrtle Avenue.
3. At the traffic circle, take 2nd exit onto Indianola Cutoff.
4. Exit the traffic circle onto Indianola Cutoff.
5. Turn right onto **US-101 North** / Michael J. Burns Memorial Fwy (signs for Arcata).
6. Use the right lane to take the CA-255 / Samoa Boulevard ramp to Arcata.
7. Keep right, follow signs for Sunny Brae.
8. At the traffic circle, take the 2nd exit and stay on Samoa Blvd.
9. Exit the traffic circle onto Samoa Blvd.
10. Turn left onto Crescent Way.
11. Turn right onto Bayside Rd.
12. Arrive at location: Sunny Brae Animal Clinic.
