Grounds Information

These events will be held on private property. Please be respectful of the owners and their home and business.

- Park in the lot designated as RV parking. Follow those signs. Do not park by the kennel buildings.
- Clean up after your dog(s). Dispose of dog waste in buckets specifically for that purpose. Please do not use the garbage bins for dog waste.
- Dispose of garbage in containers placed on the show grounds.
- Only **solid-bottom crates** (plastic trays) are allowed in the covered arena where the rings are located. **NO EX-PENS ARE ALLOWED IN THE COVERED ARENA.**
- Exhibitors may also place setups on the Lake Lawn area near by. All crates, mats or anything with a solid bottom must be pulled off the lawn at the end of the day. Nothing should be left on the lawn overnight.
- Do not allow your dog(s) to dig at the lawn or artificial turf areas.
- Absolutely no dogs or people are permitted on the dock or in the pool, including entrance and exit ramps.
- Exhibitors should bring their own meals and snacks. No food vendors are available on site.

Bitches in Season

Bitches in season are not permitted to compete. If a female is withdrawn from competition for coming into season and the Trial Secretary is notified no later than ½ hour prior to the start of the first class, then the club will refund the entry fee. A processing fee of \$8.00 per entry will be retained. A signed veterinarian's letter stating the bitch is in season must be provided as documentation with the request or within one week of the trial at the latest to receive a refund.

Clean Up Is Your Responsibility !!!

If your dog soils the grounds it is your responsibility to clean it up. By signing the entry form for these dog shows you are agreeing that clean up is your responsibility. Violators maybe reported to the event committee for disciplinary action.

Directions to Trial Site -- Sycamore Lane Kennels, 5111 W. Sargent Road, Lodi, CA 95242

From Interstate 5 - Take Hwy 12 exit (Lodi/Rio Vista). Head east for 1.3 miles to Ray Road. Turn left onto Ray Road and go almost one mile to the first curve. At the curve, turn left onto Sargent Road and follow the signs to Sycamore Lane Kennels and the show site.

From Hwy 99 - Take the Kettleman / Hwy 12 exit. Head west and proceed through Lodi. From the last traffic signal (Lower Sacramento Road), it is 3.5 miles to Ray Road. Turn right onto Sargent Road and follow signs to Sycamore Lane Kennels.

Day Parking



Parking is provided and managed by ALL DOGS SPORTS PARK LLC. & SYCAMORE LANE KENNELS AND FARM. There is no charge for day of show parking. Parking is available from 7:00 AM to two hours after the event concludes. Day parking vehicles may not remain on the grounds overnight.
