- Pre-entry fees are \$10 first run / \$8 each additional run same dog. Pre-entries must be received by September 11, 2026. Please use one sign-up form per dog. No refunds will be made after Sept 11.
- Late entry fees (received after Sept 11) are \$12 first run, \$10 each additional run same dog. Limited day-of-match entries may be allowed if space is available. All entries close September 18 @ 12:00 Noon.
- Starting time: 10:00 AM with highest level class. There will be one ring for obedience, one ring for rally. Start times for each subsequent level will depend on number of entries. An approximate judging schedule will be published on-line after Sept 13.
- NO FOOD will be allowed in the rings. Toys are allowed.
- Mixed and rare breeds welcome. Collars should comply with AKC regulations. Special training collars (such as prong collars, e-collars, head harnesses, etc) are not permitted on the show grounds or in the rings. Corrections limited to verbal corrections or gently guiding the dog.

- **VACCINATION POLICY.** In accordance with California State Law, all dogs are required to be immunized for Canine Rabies. We also recommend all dogs to be immunized for Canine Influenza Virus, Canine Parvovirus, Distemper Virus, Canine Adenovirus, and Canine Leptospira.
- If your dog has **NOT** been immunized, you must initial the box below to indicate that you know the risk and that you assume any and all risks to your dog's health should he/she come in contact with any canine virus before, during or after your dog's participation in this event.
