Grounds Information

These events will be held on private property. Please be respectful of the owners and their home and business.

- Park in the lot designated as RV parking. Follow those signs. Do not park by the kennel buildings.
- Clean up after your dog(s). Dispose of dog waste in buckets specifically for that purpose. Please do not use the garbage bins for dog waste.
- Dispose of garbage in containers placed on the show grounds.
- Only **solid-bottom crates** (plastic trays) are allowed in the covered arena where the rings are located. NO EX-PENS ARE ALLOWED IN THE COVERED ARENA.
- Exhibitors may also place setups on the Lake Lawn area near by. All crates, mats or anything with a solid bottom must be pulled off the lawn at the end of each day. Nothing should be left on the lawn overnight.
- Do not allow your dog(s) to dig at the lawn or artificial turf areas.
- Absolutely no dogs or people are permitted on the dock or in the pool, including entrance and exit ramps.

Clean Up Is Your Responsibility !!!

If your dog soils the grounds it is your responsibility to clean it up. By signing the entry form for these dog shows you are agreeing that clean up is your responsibility. Violators maybe reported to the event committee for disciplinary action.

Exhibitors should follow their veterinarian's recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Notice To Exhibitors

- **CONDITIONAL, UNSIGNED, INCOMPLETE, or telephoned entries will not be accepted.** Entries without fees cannot be accepted. See Page 6 for information on emailed entries.
- **ENTRIES NOT ON OFFICIAL AKC FORMS** or photocopies of entry forms without the [Agreement](#) and Instructions on the reverse side of the official AKC entry form are NOT ACCEPTABLE.
- **PLEASE TYPE OR PRINT CLEARLY** using black or blue ink.
- **OWNERS ARE RESPONSIBLE FOR ERRORS** on entry blanks, for entering the same dog twice, or for entering a dog in a class in which it is ineligible to compete, regardless of who makes such errors.
- **CHANGES, ADDITIONS, OR CORRECTIONS** to entry forms must be received in writing prior to close of entries. Emailed changes are acceptable. Changes by telephone are not acceptable.
- **RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE.** There will be a \$25.00 collection fee added to the amount of each returned check. Subsequent returned checks from the same exhibitor may result in their being put on a CASH ONLY basis.
- Each entry of a dog in a Licensed or Member Obedience Trial includes \$4.50 AKC Recording / Event Service Fee. Each entry in a Licensed or Member Rally Trial includes \$4.50 AKC Recording Fee. These fees are already included in the fee schedule shown. (Effective Jan 1, 2026)
- **BITCHES IN SEASON** are not permitted to compete. If a female is withdrawn from competition for coming into season and the Trial Secretary is notified no later than ½ hour prior to the start of the first class, then the club will refund the entry fee. **A processing fee of \$8.00 per entry will be retained.** A signed veterinarian's letter stating the bitch is in season must be provided as documentation with the request or within one week of the trial at the latest to receive a refund.
- **ENTRY FEES WILL NOT BE REFUNDED** in event of errors or cancellation of entries after the published closing date, nor in the event a dog is absent, disqualified, sick, lame, excused by the Veterinarian or Judge, or barred from competition by the Trial Committee.
- **THE WELL-BEING OF DOGS** and participants is of paramount importance. If, because of riots, civil disturbances, loss of site, fire, Act of God, act of a public enemy, strikes, extreme weather conditions (including but not limited to extreme heat, floods, snow storms, hurricanes, lightning, or earthquakes), or any other acts beyond the control of the management, it is impossible to open or complete the trial, no refunds of entry fee(s) will be made. **DO NOT LEAVE ANIMALS IN A HOT VEHICLE.**
- **RECEIPT OF ENTRY.** An emailed acknowledgement will be sent upon receipt of entry to the email address listed on the entry form. If exhibitor does not hear within a reasonable time, please contact the Trial Secretary before closing date.
- **THE JUDGING SCHEDULE** with armband assignment will be sent to the email address on the Official AKC entry form approximately one week before the trial. If the exhibitor wishes to have a **printed** schedule mailed, please request on the entry form.
- **CONSULT JUDGING PROGRAM** for time of judging. Exhibitors are responsible for having their dogs at ringside when it is their turn to be judged. Dogs need to be at the trial only at scheduled time of judging and may leave immediately after unless required for further judging.
- **DOGS MUST BE KEPT ON LEASH** except when being judged in the ring.
- **THERE SHALL BE NO DRILLING** nor intensive or corrective training of dogs on the show grounds or premises.
- **NO PROVISIONS** will be made for unentered dogs on the grounds.
- **IN THE CASE OF A TIE** for any prize, any dog that is not present for a run-off will forfeit its rights to the prize.
- **ALL AWARDS MUST BE CLAIMED THE DAY OF THE TRIAL. NONE WILL BE MAILED** or delivered. An exhibitor whose dog is eligible for an award must be present or appoint a representative to accept the award.
- **THE TRIAL-GIVING CLUB, THE TRIAL SECRETARY,** their agents or employees assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, spectators, or to any of their dogs or property, and further assume no responsibility for injury to any **CHILD** not under the control of their parents or guardians.
- **SPECIAL ATTENTION:** No owner or agent shall allow his/her animals to be put in jeopardy of the elements. To do so may result in damaged vehicles during rescue attempts by the event committee.
