- **CLASS TRANSFERS "Move-Ups"** are allowed at this trial for dogs completing a title after close of entries. The request must be made in writing at least 30 minutes prior to the start of the trial (earlier preferred if possible).
- **ARMBANDS** will be at Trial Secretary's desk each morning. Check into ring after picking up armbands.
- **BITCHES COMING INTO SEASON** after the closing date for entries may have the entry fee refunded less \$6.00 per class upon written verification of a Veterinarian before the start of judging of the Trial on the day of the Trial the dog was entered.
- **RALLY COURSE MAPS:** Will be available for exhibitors upon check-in at the ring.
- **TRIAL CATALOGS** - If you ordered a trial catalog on your entry form, it will be available at the Trial Secretary desk. A few additional catalogs may be available for purchase at the trials for \$5.00.
- **CLEAN-UP:** Exhibitors are responsible for cleaning up after their dogs.

TRAVELING SOUTH ON HWY 97:

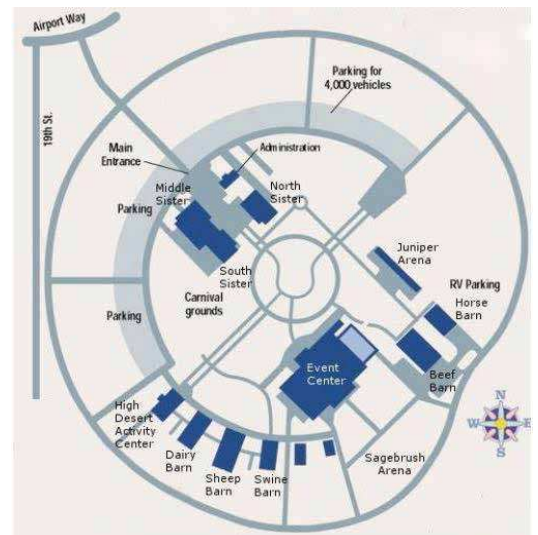
Take Yew Avenue Exit, then turn left to go east on Airport Way toward Redmond Airport. Fairgrounds will be on the right.
