- *Compete in Open B and Utility B at all three of the trials identified as an AKC regional competition.*
- *Have a cumulative score obtained from the dog's participation in Open B and Utility B at the regional competition.*
- *Be ranked from highest to lowest based on their cumulative score with 1200 points being a perfect score.*
- *Qualify by cumulative score as one of the top four at one regional competition for an invitation to the National Obedience Championship.*

Obedience Class Information

Exhibitors must specify their dog's obedience jump height on entry form for classes with jumps.

Dogs will be separated by jump height and run in **ASCENDING order starting at 4"**.

Dogs without jump heights on entry form will be judged at the end of the class.

Non-Regular Obedience Classes are offered as listed below. See Page 3 for entry fees.

- **VETERANS**, offered Friday and Saturday only. The Veterans class will be for dogs that have an obedience title and are at least 7 years old on the date of the trial. The exercises will be performed and judged as in the Novice class.
- **OBEDIENCE BRACE**, offered Saturday only. For two dogs (including dogs listed with AKC Canine Partners) of similar height at the withers that are eligible under these regulations and capable of performing the Novice exercises. The dogs need not be owned by the same person but will be handled by one handler. Dogs may be shown unattached or coupled. A separate official entry form must be completed in full for each dog entered, please send entry forms together. Either or both dogs in Brace may be entered in another class or classes.

Obedience Trial Prizes

Qualifying scores are required for prizes in the Regular, Preferred and Optional Titling classes.

Qualifying scores are not required in Non-Regular classes.

A Dark Green Qualifying Score Ribbon will be awarded to each dog with a qualifying score in Regular, Preferred, and Optional Titling Obedience classes.

Rally classes with jumps will be run in **ASCENDING order starting with 4"**.

Rally ring size to be 40' x 50'.

The Non-Regular Rally Classes listed below are offered all three days.

- **RALLY PAIRS NOVICE.** Rally Pairs class consists of competition by one handler working two dogs at one time through a rally course. An official entry form must be completed for each dog. Please send entry forms together. See Page 3 for entry fees.
- **RALLY TEAM NOVICE, RALLY TEAM INTERMEDIATE, RALLY TEAM ADVANCED.** Rally Team is for any four dogs that are eligible. Five dogs may be entered, one to be considered an alternate for which no entry fee will be required. The same four dogs will perform all exercises. All team members will run the course individually, with the team time running continuously. For Advanced, the jump height will be based on the smallest dog on each competing team. No dog may be entered on more than one team. However, one person may handle more than one dog on a Team, as Rally Team is like a relay with one dog going after another. A separate entry form must be completed in full for each dog entered. When entering please designate a TEAM NAME on each entry form to allow for catalog numbering. See Page 3 for entry fees.
