Class Transfers

Class Transfers Are Allowed provided the class is scheduled, the judge is available, and the class has not reached its limit. Transfer requests must be in writing and will be accepted from the day after close of entries until 30 minutes before the start of the trial.

Clean Up Is Your Responsibility !!!

If your dog soils the grounds it is your responsibility to clean it up. By signing the entry form for these dog shows you are agreeing that clean up is your responsibility. Violators maybe reported to the event committee for disciplinary action.

Grounds Information - Four Paws Training, Martinez, CA

1. NO overnight and NO day of RV parking.
2. NO smoking allowed on the grounds.
3. There will be a door monitor, you may not enter the building on your own.
4. Once you exit the ring, you will need to exit the building.
5. You will not be allowed to watch from inside the building.
6. **CHECK-IN** will be done outside the building.
7. **NO CRATING IN THE BUILDING.** You will be required to crate from your vehicle. Bring canopies and/or shade cloth. Please keep dogs quiet. If barking cannot be controlled, you will be asked to leave. Keep dogs on leash while not working in the judging ring.
8. **NO DOG POTTY AREA ON SITE**, but there is a lawn a block away on Ward Street. Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations near the show grounds.

Bitches in Season

Bitches in season are not permitted to compete. If a female is withdrawn from competition for coming into season and the Trial Secretary is notified no later than ½ hour prior to the start of the first class, then the club will refund the entry fee. A processing fee of \$8.00 per entry will be retained. A signed veterinarian's letter stating the bitch is in season must be provided as documentation with the request or within one week of the trial at the latest to receive a refund.

Directions to Trial Site - Four Paws Training, 730 Las Juntas St., Martinez, CA 94553

From Hwy 680 going Northbound (from Walnut Creek):

- Exit 56 Marina Vista Ave to downtown Martinez (last exit before bridge).
- Continue westbound on Marina Vista to Ferry St.
- Turn left on Ferry St, go 2 blocks.
- Turn left on Main Street go 1 block.
- Turn right on Las Juntas St, and right into parking lot.

From Hwy 80 / Hwy 4 (from Oakland / Richmond):

- Take Hwy 4 East to Exit 9: Alhambra Ave. in Martinez.
- Turn left at bottom of ramp toward downtown Martinez.
- Go approximately 2 miles and turn right onto Ward Street.
- Turn left on Las Juntas St., and immediately turn left into parking lot.

From Hwy 680 going Southbound (from Cordelia / Benicia):

- Take Hwy 680 south and cross the Benicia Bridge.
- Take Marina Vista Ave to downtown Martinez.
- Go westbound on Marina Vista to Ferry St.
- Turn left on Ferry St, go 2 blocks.
- Turn left on Main Street go 1 block.
- Turn right on Las Juntas St, and right into parking lot

Parking:

- **ADDITIONAL PARKING** is available across both Las Juntas and Ward Streets.
- **Street parking** is also available, the meters are not checked on weekends.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Directions to Veterinarian (from Trial Site):

- From parking lot go onto Ward Street.
- Go one block, then turn right onto Ferry St.
- Go two blocks and turn right onto Escobar.
- Continue onto Marina Vista eastbound about 1.4 m, take ramp and enter I-680 southbound.
- Take Interstate-680 south for 4 miles.
- Exit on Concord Ave (Exit 52) in Concord.
- Use left two lanes and turn left onto Contra Costa Blvd.
- Use left two lanes to turn left onto Concord Ave.
- Go 0.3 miles, turn right onto Meridian Park Blvd.
- In 0.3 miles turn right into parking lot.
- SAGE VET will be on your left across from DMV.
