Non-Regular Classes Involving Single Dog Entries

Veteran Dogs, 7 years & under 9 years Veteran Dogs, 9 years & older Veteran Bitches, 7 years & under 9 years Veteran Bitches, 9 years & older

Neutered dogs and spayed bitches may compete in the Veterans Classes at Independent Specialties. The first place Winner of these classes, if undefeated in the show, is eligible to compete for Best of Breed Competition.

Best of Breed

The following categories of dogs may be entered and shown in Best of Breed or Variety competition: Dogs that are Champions of Record, or Dogs which according to their owners' records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the day of the show where a dog completed the requirements for a championship according to the owners' records.

Special Conformation Awards

- **Owner-Handled** Exhibitors must declare their dog is eligible for AKC National Owner-Handled Series (NOHS) at the time of entry using the **CHECK BOX** on the entry form. See information on Page 5.
- Awards of Merit The judge may select, at his/her discretion up to 10% of the superior quality specimens from the intersex competition. These would not include those exhibits previously awarded Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog/Bitch, Best of Winners, or Winners Dog/Bitch.
- **Best Puppy** Chosen from the winners of the puppy classes including BBE Puppy. If an entrant from a Puppy class is chosen Best of Breed or Best of Winners, then it is automatically awarded Best Puppy.
- **Best Bred-By** Chosen from the winners of the BBE classes. If an entrant from a BBE class is chosen Best of Breed or Best of Winners, then it is automatically awarded Best BBE.
- **Best Veteran** Chosen from the winners of the Veteran classes. If an entrant from a Veteran class is chosen Best of Breed, then it is automatically awarded Best Veteran.

Non-Regular Classes Involving Multiple Dog Entries

Stud Dog Class - For Stud dogs and two of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog may be entered in one of the Regular or Non-Regular Classes or, if a Champion of Record, the Best of Breed competition, but must be entered in the Stud Dog class. The Stud dog may be entered in the Stud Dog Class only at the regular entry fee. The Get must be entered in one of the Regular Classes or, if a Champion of Record, in the Best of Breed competition. The Stud Dog shall be considered one entry and requires one entry fee. The Stud Dog must be shown in the ring with the Get. The class will be judged based on the merits of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the dog show rules, AKC policy, or the standard of the breed. The Stud Dog need not be intact.

Brood Bitch Class - same as for Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get.

Brace Class - A Brace is defined as two dogs of the same recognized breed or variety that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs competing in brace competition must have at least one common owner and be entered in another conformation class. The dogs comprising a Brace must be named at the time the entry is made, indicate Brace in the space provided for "Additional Class." Please submit brace entries together.

As the judge's decision in the Stud Dog, Brood Bitch, and Brace classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to complete for Best of Breed by virtue of having won either of these classes.

AKC National Owner-Handled Series

Remember to check the box near the bottom of the entry form.

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form.

Dogs entered in the Amateur-Owner-Handler class will automatically be marked as eligible to compete in the NOHS.

Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner.

Professional handlers*, household members and current assistants** to professional handlers may not exhibit the dog in any NOHS competition during the entire show.

* Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.

** A current assistant is defined as anyone employed by a professional handler on a full-time basis or assisting a professional handler at the show or any time during the cluster/weekend. Current assistants that are eligible to compete in Junior Showmanship (meet age & amateur status requirements) may participate in NOHS.

Junior Showmanship

<u>An AKC Junior Handler Number</u> is required for entry in Junior Showmanship Competition. Numbers may be obtained from the American Kennel Club at phone (919) 233-9767, or online at juniors@akc.org. For additional information contact the American Kennel Club at 5580 Centerview Drive, Raleigh, NC 27606. When entering this show, be sure to include all information required on both the front and back of the Official AKC Entry Form.

Junior Showmanship Classification

Novice Senior 15 yrs & under 18 yrs Open Senior 15 yrs & under 18 yrs

Novice Classes - For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards in a Novice Class with competition present. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

Open Classes - For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

Master Class - For boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

Best Junior Handler - Selected from the winners of each Junior Showmanship class. Competition not required.

Reserve Best Junior Handler - After the judge has awarded the Best Junior Handler, the second place winner from the class that the Junior was awarded Best Junior Handler is to return to the ring to compete for Reserve Best Junior Handler.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.

Substitutions - A dog may be substituted in Junior Showmanship. Such substitution must be accompanied by an official AKC entry form. All such substitutions must be made $\frac{1}{2}$ hour prior to the judging of the Junior Showmanship classes at the show. All eligibility criteria above must be met. A Junior Handler is limited to one substitution per show.

Open to Portuguese Podengo Pequenos at least six (6) months of age and under eighteen (18) months of age on the day of the show. Dogs entered in any Sweepstakes Class must be entered in a Regular conformation class in the National Specialty at the regular fee. Entries shall be made at the same time, on the same form as form as for Regular Classes. Indicate "Sweepstakes" and the age and coat division in the space for "Additional Classes"

Entries shall be made at the same time, on the same entry form as for Regular Classes. Indicate "Veteran Sweepstakes", stating age/class division in the space for "Additional Classes".

Futurity Stakes Eligibility

The Portuguese Podengo Pequeno must be entered in one of the regular classes at the PPPA Specialty Show if the Futurity is held in conjunction with the Specialty Show. If the Futurity is held in conjunction with an all-breed show, the dog must be entered in one of the regular classes at the show . When completing the entry form, the fact that the dog is to be shown in the Futurity must be indicated on the entry form. The entry fee for the Futurity class is an additional fee. This fee should be included with the regular entry fee for the class at the show.

No Portuguese Podengo Pequeno will be eligible to compete in the Futurity which does not meet the following requirements:

- 1. Be from a litter which was nominated in a proper and timely fashion.
- 2. Have been individually nominated before it reached the age of four months.
- 3. Be properly entered in one of the Regular Classes at the show.
- 4. "Futurity Stakes" is to be written in as an additional class on the AKC entry form with the age / coat division.

Monetary Awards

1. NOMINATION FEES:

35% shall be deducted from the total nomination fee purse to be used for Futurity expenses. This will be deposited in the PPPA Treasury. This fund shall cover all expenses incurred by the Futurity Stake i.e. judges, printing, mailing, etc.

The remaining 65% will be awarded as follows:

60% Best in Futurity Divided as 60% to Breeder of Record and 40% to Owner of Record

40% Best of Opposite Sex to Best in Futurity Divided as 60% to Breeder of Record and 40% to Owner of Record

2. ENTRY FEES

35% shall be deducted from the total entry fee purse to be used for Futurity expenses and will be held in the PPPA Treasury. The remaining 65% will be awarded as follows:

Entries....... 40% - First, 30% - Second, 20% - Third, 10% - Fourth. If fewer than four competitors, the balance will be divided among placements in that class. All placements will be divided such: 60% Breeder of Record, 40% Owner of Record.

- **3. Ribbons** shall be awarded first through fourth place in each class. Rosettes shall be given to Best in Futurity and Best of Opposite in Futurity.
- 4. **Monetary Awards** which are provided for, but cannot be given, whatever the reason, shall be retained by the Club.

The Portuguese Podengo Pequeno must be entered in one of the Regular classes at the PPPA Specialty Show if the Maturity is held in conjunction with the Specialty Show. If the Maturity is held in conjunction with an all-breed show, the dog must be entered in one of the Regular classes at the show . When completing the entry form, the fact that the dog is to be shown in the Maturity must be indicated on the entry form. The entry fee for the Maturity class is an additional fee. This fee should be included with the regular entry fee for the class at the show.

No Portuguese Podengo Pequeno will be eligible to compete in the Maturity which does not meet the following requirements:

- 1. Be from a litter which was nominated in a proper and timely fashion.
- 2. Have been individually nominated before it reached the age of four months.
- 3. Be properly entered in one of the Regular classes at the show.
- 4. "Maturity Stakes" is to be written in as an additional class on the AKC entry form with the age / coat division.

Maturity Classes

Maturity Dogs, 18 months and under 24 months (smooth / wire) Maturity Dogs, 24 months and under 30 months (smooth / wire) Maturity Bitches, 18 months and under 24 months (smooth / wire)

Winners of each of these classes will compete for Best and Best of Opposite Sex in Maturity.

1. NOMINATION FEES:

Maturity Monetary Awards

35% shall be deducted from the total nomination fee purse to be used for Maturity expenses. This will be deposited in the PPPA Treasury. This fund shall cover all expenses incurred by the Maturity Stake i.e. judges, printing, mailing, etc.

The remaining 65% will be awarded as follows:

60% Best in Maturity Divided as 60% to Breeder of Record and 40% to Owner of Record

40% Best of Opposite Sex to Best in Maturity Divided as 60% to Breeder of Record and 40% to Owner of Record

2. ENTRY FEES

35% shall be deducted from the total entry fee purse to be used for Maturity expenses and will be held in the PPPA Treasury. The remaining 65% will be awarded as follows:

Entries....... 40% - First, 30% - Second, 20% - Third, 10% - Fourth. If fewer than four competitors, the balance will be divided among placements in that class. All placements will be divided such: 60% Breeder of Record, 40% Owner of Record.

- **3. Ribbons** shall be awarded first through fourth place in each class. Rosettes shall be given to Best in Maturity and Best of Opposite in Maturity.
- 4. **Monetary Awards** which are provided for, but cannot be given, whatever the reason, shall be retained by the club.

- FSS number or FSS registered litter number will be required for Miscellaneous and FSS breed entries.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler.

AGREEMENT

 (Variety) If you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in, over 13 in. but not exceeding 15 in), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which according to their owners records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any show for which entries close after the date acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to A.K.C. (For complete rule refer to Chapter 11, Section 3).

5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
