- Dogs will be separated by jump height and run in **ASCENDING order starting at 4"**.
- Dogs without jump heights on entry form will be judged at the end of the class.
- Obedience entries are limited to 30 entries.
- UDX class offered.

## Rally Trial Information

- Exhibitors must specify the dog's rally jump height for Advanced, Excellent, Master classes
- Rally classes with jumps will be run in **ASCENDING order starting with 4"**.
- Rally entries are limited to 30 entries.
- RAE and RACH classes are offered.
- Rally ring size to be 40' x 50'.

## Notice To Exhibitors

---

- **CONDITIONAL, UNSIGNED, INCOMPLETE, or telephoned entries will not be accepted.** Entries without fees cannot be accepted.
- **ENTRIES NOT ON OFFICIAL AKC FORMS** or photocopies of entry forms without the **Agreement** and Instructions on the reverse side of the official AKC entry form are NOT ACCEPTABLE.
- **PLEASE TYPE OR PRINT CLEARLY** using black or blue ink.
- **OWNERS ARE RESPONSIBLE FOR ERRORS** on entry blanks, for entering the same dog twice, or for entering a dog in a class in which it is ineligible to compete, regardless of who makes such errors.
- **CHANGES**, additions, or corrections to entry forms must be received in writing prior to close of entries. Email and faxed changes are acceptable. Changes by telephone are not acceptable.
- **An AKC RECORDING AND EVENT SERVICE FEE** of \$3.50 will be required for every entry in any Licensed or Member Club Show, Obedience Trial or Tracking Test. **Rally:** An AKC Recording Fee of \$3.50 will be required for every entry in a Licensed or Member Rally Trial. These fees are included in the prices shown and are paid to the American Kennel Club.
- **ENTRY FEES WILL NOT BE REFUNDED** in event of errors or cancellation of entries after the published closing date, nor in the event a dog is absent, disqualified, sick, lame, excused by the Veterinarian or Judge, or barred from competition by the Trial Committee.
- **THE WELL-BEING OF DOGS** and participants is of paramount importance. If, because of riots, civil disturbances, loss of site, fire, Act of God, act of a public enemy, strikes, extreme weather conditions (including but not limited to extreme heat, floods, snow storms, hurricanes, lightning, or earthquakes), or any other acts beyond the control of the management, it is impossible to open or complete the trial, no refunds of entry fee(s) will be made. **DO NOT LEAVE ANIMALS IN A HOT VEHICLE.**
- **BITCHES IN SEASON** are not permitted to compete. If a female is withdrawn from competition for coming into season and the Trial Secretary is notified no later than ½ hour prior to the start of the first class, then the club will refund the entry fee. **A processing fee of \$10.00 per entry will be retained.** A signed veterinarian's letter stating the bitch is in season must be provided as documentation with the request or within one week of the trial at the latest to receive a refund.
- **ELECTRONIC CONFIRMATION OF ENTRY & SCHEDULE OF JUDGING TIME** will be sent to the email address on the Official AKC entry form after the closing date. If the exhibitor wishes to have a **printed** schedule mailed, please request on the entry form. If an exhibitor has not received a copy of the schedule within seven days of the trial, the Trial Secretary should be contacted.
- **DOGS NEED TO BE AT THE TRIAL** only at scheduled time of judging and may leave immediately after unless required for further judging.
- **CONSULT JUDGING PROGRAM** for time of judging. Exhibitors are responsible for having their dogs at ringside when it is their turn to be judged. Dogs not required for further judging may be excused after their class has been judged.
- **DOGS MUST BE KEPT ON LEASH** except when being judged in the ring.
- **THERE SHALL BE NO DRILLING** nor intensive or corrective training of dogs on the show grounds or premises.
- Unentered dogs are not allowed in the trial building. No provisions will be made for unentered dogs on the grounds.
- In the case of a tie for any prize, any dog that is not present for a run-off will forfeit its rights to the prize.
- **ALL AWARDS MUST BE CLAIMED THE DAY OF THE TRIAL. NONE WILL BE MAILED** or delivered. An exhibitor whose dog is eligible for an award must be present or appoint a representative to accept the award
- **THE TRIAL-GIVING CLUB, THE TRIAL SECRETARY,** their agents or employees assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, spectators, or to any of their dogs or property, and further assume no responsibility for injury to any child not under the control of their parents or guardians.
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

## Crating Rules

---

- **Crating of entered dogs is allowed in the building provided these rules are followed:**
- Please put a CLEAN towel and/or CLEAN mat under your CHAIR and CRATE to protect the matted surface and keep it clean.
- NO X-pens in the building.
- NO crate-aggressive dogs in the building. Please keep dogs quiet, if barking cannot be controlled you will be asked to leave.
- A dog not entered in the trial is not allowed in the building.
- You may only crate in the marked crating area between the RED CONES! Space is limited. No dogs on the couch!
- If indoor crating fills up, additional crating is allowed on the patio on the side of the building. Handlers may also work out of their car. Regardless of where handlers crate their dog, it is each handler's responsibility to know when it is their turn in the ring, and to be ready to go in the ring when it is their turn.

---

## Parking Information, Grounds, and Trial Procedures

---

- **NO OVERNIGHT & NO RV PARKING** is allowed. RV's are not allowed on the grounds.
- **NO SMOKING** is allowed on the grounds.
- **VEHICLES MAY NOT BE LEFT IDLING** in the parking area.
- **PARKING IS LIMITED.** Obedience exhibitors should not arrive more than one hour before earliest class. Rally exhibitors may arrive any time after 12:00 Noon. If your class is completed and the parking area is near capacity, please leave to give space to another entrant.
- **CLEAN-UP.** Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds. Potty your dog in dog run or on gravel driveway. Do not potty dogs on grass, plants, barn, equipment, side of building, or back of building. Do not allow your dog to potty within 20' of the building.
- Every precaution for the safety of dogs and exhibitors will be exercised, but neither the Club nor the management will be responsible for loss or injury.
- Only dogs that are eligible to be shown under AKC rules shall be allowed within the show precincts (inside building).
- All dogs must be ON-LEASH at all times while on show grounds and parking areas unless in the ring for judging.
- Retractable leashes (Flexi-Leads) are permitted, but not to be extended beyond 6 feet in length indoors.
- **PLEASE KEEP DOGS QUIET.** If barking cannot be controlled, you will be asked to leave.
- Please stay away from the house area.
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
- Consult the judging schedule (on previous page) for the time of judging. Exhibitors and handlers are responsible for the presence of their dogs in the judging ring. The Club assumes no responsibility for this.
- **NO FOOD VENDORS** will be available at this event. Exhibitors should plan to bring their own snacks and beverages. Fast food is available approximately 15 minutes away.
- **WATER:** Well water is available and safe to drink. Note: Farm animals and cats are present on property. Please stay away from house area.

## Rally Championship

Rally Trial Championship points and triple qualifying scores will be recorded for dogs after they have earned the Rally Excellent (RE) title. When a dog earns the Rally Championship title, it may continue to compete and earn points.

Rally Championship points will be recorded for dogs earning a score of 91 or better in the Rally Advanced B, Rally Excellent B and Rally Master classes. A dog must earn a total of 300 points, with a minimum of 150 points from the Master class. Additionally, the dog must receive qualifying scores in Advanced B, Excellent B and the Master class on the same day at the same trial at 20 separate licensed or member rally trials.

The AKC will issue a Rally Champion certificate and will permit the use of the letters RACH preceding the name of each dog that meets the requirements.

The letters RACH will be followed by a numeric designation indicating the number of times a dog has met the requirements of the RACH title as defined in the Regulations. (RACH2 for 40 triple qualifying scores and 600 points, RACH3 for 60 triple qualifying scores and 900 points, etc.)



## Obedience Trial Championship

Obedience Trial Championship points will be recorded for those dogs that have earned a first, second, third or fourth place ribbon competing in the Open B or Utility B class, according to the schedule of points established by the AKC Board of Directors. When counting the number of eligible dogs in competition, a dog that is disqualified or excused from the ring by the judge will not be included.

One (1) Championship point will be recorded for those dogs that earn a qualifying score of 197 or better in the Open B or Utility B class, if they did not earn points based on the Point Schedule.

Requirements for the Obedience Trial Champion are as follows. The dog must have won:

1. 100 points
2. A first place in Utility B with at least three dogs in competition
3. A first place in Open B with at least five dogs in competition
4. An additional first place under the conditions of 2 or 3 above
5. All three first places under three different judges

Only one of the required first places may have been won at a specialty Show or a Junior Obedience Showcase.

Obedience Trial Champion Title. The AKC will issue an Obedience Trial Champion certificate and will permit the use of the letters OTCH preceding the name of each dog that meets the requirements. The letters OTCH will be followed by a numeric designation indicating the number of times a dog has met the requirements of the OTCH title as defined in these regulations (OTCH2, OTCH3, OTCH4, etc.).
