THIS IS AN AKC-SANCTIONED MATCH, with the following limitations and requirements. COLLARS must comply with AKC Regulations – no prong or electronic collars on grounds. Physical corrections are NOT allowed. Corrections are limited to verbal or gently guiding the dog. Food and/or toys are allowed in the rings, but please keep food off the ground. Exercises may be repeated at Judge's discretion.

NO DRIVING ONTO THE SHOW GROUNDS IS ALLOWED!!! You must park in the parking lot and be prepared to haul your equipment to the show area (on paved paths). Limited shaded areas under trees are available.

DIRECTIONS FROM HWY 880 IN HAYWARD, take the Jackson Street exit eastbound and continue to Mission Blvd. Turn right onto Mission Blvd. Turn left onto Carlos Bee Blvd, go up hill, and stay to right to enter campus. At stop sign, turn left and follow the Loop Road to the back of the campus. Turn right, go one block, and turn right again into **PARKING LOT K (Theater).**

DIRECTIONS FROM OAKLAND AREA, proceed eastbound on Hwy 580 to Hayward and take the Hayward exit. Continue along Foothill Blvd, turn right on "A" Street, left onto Mission. Turn left onto Carlos Bee Blvd, go up hill, and stay to right to enter campus. At stop sign, turn left and follow the Loop Road to the back of the campus. Turn right, go one block, and turn right again into Parking Lot K.

DIRECTIONS FROM DUBLIN AREA, proceed westbound on 580 and take the Strobridge exit in Castro Valley. Turn right, go one block, and turn left onto Castro Valley Blvd. Stay to left and follow to Hayward, going under the freeway maze. Turn left onto Foothill, turn right on "A" Street, left onto Mission. Turn left onto Carlos Bee Blvd, go up hill, and stay to right to enter campus. At stop sign, turn left and follow the Loop Road to the back of the campus. Turn right, go one block, and turn right again into Parking Lot K.
