



Notice To Exhibitors

- CONDITIONAL, UNSIGNED, INCOMPLETE, or telephoned entries will not be accepted. Entries without fees cannot be accepted. See Page 4 for information on emailed entries.
- **ENTRIES NOT ON OFFICIAL AKC FORMS** or photocopies of entry forms without the **Agreement** and Instructions on the reverse side of the official AKC entry form are NOT ACCEPTABLE.
- PLEASE TYPE OR PRINT CLEARLY using black or blue ink.
- **OWNERS ARE RESPONSIBLE FOR ERRORS** on entry blanks, for entering the same dog twice, or for entering a dog in a class in which it is ineligible to compete, regardless of who makes such errors.
- **CHANGES**, additions, or corrections to entry forms must be received in writing prior to close of entries. Email and faxed changes are acceptable. Changes by telephone are not acceptable.
- An AKC RECORDING AND EVENT SERVICE FEE of \$3.50 will be required for every entry in any Licensed or Member Club Show, Obedience Trial or Tracking Test. <u>Rally:</u> An AKC Recording Fee of \$3.50 will be required for every entry in a Licensed or Member Rally Trial. These fees are included in the prices shown and are paid to the American Kennel Club.
- ENTRY FEES WILL NOT BE REFUNDED in event of errors or cancellation of entries after the published closing date, nor in the event a dog is absent, disqualified, sick, lame, excused by the Veterinarian or Judge, or barred from competition by the Trial Committee.
- THE WELL-BEING OF DOGS and participants is of paramount importance. If, because of riots, civil disturbances, loss of site, fire, Act of God, act of a public enemy, strikes, extreme weather conditions (including but not limited to extreme heat, floods, snow storms, hurricanes, lightning, or earthquakes), or any other acts beyond the control of the management, it is impossible to open or complete the trial, no refunds of entry fee(s) will be made. DO NOT LEAVE ANIMALS IN A HOT VEHICLE.
- BITCHES IN SEASON are not permitted to compete. If a female is withdrawn from competition for coming into season and the Trial Secretary is notified no later than ½ hour prior to the start of the first class, then the club will refund the entry fee. A processing fee of \$10.00 per entry will be retained. A signed veterinarian's letter stating the bitch is in season must be provided as documentation with the request or within one week of the trial at the latest to receive a refund.
- **ELECTRONIC CONFIRMATION OF ENTRY & SCHEDULE OF JUDGING TIME** will be sent to the email address on the Official AKC entry form after the closing date. If the exhibitor wishes to have a **printed** schedule mailed, please request on the entry form. If an exhibitor has not received a copy of the schedule within seven days of the trial, the Trial Secretary should be contacted.
- DOGS NEED TO BE AT THE TRIAL only at scheduled time of judging and may leave immediately after unless required for further judging.
- **CONSULT JUDGING PROGRAM** for time of judging. Exhibitors are responsible for having their dogs at ringside when it is their turn to be judged. Dogs not required for further judging may be excused after their class has been judged.
- DOGS MUST BE KEPT ON LEASH except when being judged in the ring.
- THERE SHALL BE NO DRILLING nor intensive or corrective training of dogs on the show grounds or premises.
- Unentered dogs are not allowed in the trial building. No provisions will be made for unentered dogs on the grounds.
- In the case of a tie for any prize, any dog that is not present for a run-off will forfeit its rights to the prize.
- ALL AWARDS MUST BE CLAIMED THE DAY OF THE TRIAL. NONE WILL BE MAILED or delivered. An exhibitor whose dog is eligible for an award must be present or appoint a representative to accept the award
- THE TRIAL-GIVING CLUB, THE TRIAL SECRETARY, their agents or employees assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, spectators, or to any of their dogs or property, and further assume no responsibility for injury to any child not under the control of their parents or guardians.
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Parking and Grounds Information

- NO RV PARKING is allowed either during the day or overnight. RV's are not allowed on the grounds.
- NO SMOKING is allowed on the grounds.
- **PARKING IS LIMITED.** Please do not arrive more than one hour before your class. If your class is completed and the parking area is near capacity, please leave to give space to another entrant.
- VEHICLES MAY NOT BE LEFT IDLING in the parking area.
- PLEASE KEEP DOGS QUIET. If barking cannot be controlled, you will be asked to leave. Dogs must be kept on leash except when working in the ring. Note: Farm animals and cats are present on property. Air your dog in dog run or on gravel driveway. Do not air dogs on grass, plants, barn, equipment, side of building, or back of building.
- CLEAN-UP. Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.
- **NO FOOD VENDORS** will be available at this event. Exhibitors should plan to bring their own snacks and beverages. Fast food is available approximately 15 minutes away.
- WATER: Well water is available and safe to drink.

Rally / Obedience Crating Rules and Trial Procedures

- <u>RALLY</u> Crating will be allowed in the building on Friday/Saturday only. <u>Crating must be between the RED CONES!</u>
 Spectators are allowed. SPACE IS LIMITED. A CLEAN towel or mat must be placed under your chair and crate to protect the matting.
- NO X-pens in the building. NO crate aggressive dogs in the building. A dog not entered in the trial is not allowed in the building. There is room to warm up outside on the patio.
- Rally exhibitors may leave their crates overnight in the building on Friday night. ALL chairs, crates, and setups must be
 removed immediately at the end of the Saturday Rally trial. The building will be emptied to be cleaned, equipment and
 furnishings moved out or rearranged, and two rings will be set up for the Sunday Obedience trial.
- <u>OBEDIENCE</u> NO INDOOR CRATING ALLOWED ON SUNDAY. SPECTATOR SEATING for viewing is allowed in the building. SPACE IS LIMITED. Chairs only will be allowed inside (bring your own chair). A CLEAN towel or mat must be placed under your chair to protect the matting.
- <u>ALL DAYS</u> Crating is allowed on the patio on the side of the building. Handlers may also work out of their car. Regardless of where handlers crate their dog, it is each handler's responsibility to know when it is their turn in the ring, and to be ready to go in the ring when it is their turn.
- NO CRATES OR CHAIRS MAY BE LEFT OUTSIDE OVERNIGHT (updated from premium list)...
- CHECK-IN will be in the building with the ring steward at the ring. There will be no door monitor, exhibitors and spectators will have access to the building during the trial.
