### **Rally Trial Judging Programs**

**PARKING IS LIMITED.** Please do not arrive more than one hour before your earliest class. If your class is completed, your dog is not required for further judging, and the parking lot is near capacity, please leave the grounds to give parking space to another entrant.

**RALLY EXHIBITORS ON FRIDAY AND SATURDAY:** Crating and seating **are allowed** inside the building. Space is limited. See Crating Rules on subsequent page.

The class start times listed are for the course walk-through, with judging to follow. To estimate starting time for classes listed as "After **Noon**", rally judging is scheduled at 20 dogs per hour. Walk-throughs will be combined for A/B classes at same level when combined entry is no more than 20. A lunch break of 45-60 minutes will be taken at approximately 12:00 Noon each day. Judges may take additional breaks at their discretion.

All judging will be held in Ring 1. No practicing is allowed in the ring at any time. Rally course maps will be available on the morning of each trial upon check-in.



- <u>CLASS TRANSFERS</u> "Move-Ups" are allowed at these trials for dogs completing a title after close of entries. The request must be made in writing to the Trial Secretary at least 30 minutes prior to the start of the trial (earlier is preferred if possible).
- <u>BITCHES IN SEASON</u> are not permitted to compete. If a female is withdrawn from competition for coming into season and the Trial Secretary is notified no later than ½ hour prior to the start of the first class, then the club will refund the entry fee. A processing fee of \$10.00 per entry will be retained. A signed veterinarian's letter stating the bitch is in season must be provided as documentation with the request or within one week of the trial at the latest to receive a refund.

#### Directions to Trial Site - Dream Big Training Center, 19681 Brandt Road, Lodi, CA 95240

• FROM STOCKTON AREA – From Hwy 99 take Hwy 88 (2 exits north of Hwy 4) to Brandt Road. Turn right onto Brandt Road going east towards the mountains. Cross Clements, take first driveway on the left.



- FROM SACRAMENTO AREA Take Hwy 99 south to Acampo. Exit on W. Peltier (exit 270) and head east for 8 miles. Turn right onto Elliott Road for 3.5 miles. Elliot will become N. Tully Road as it passes through the town of Lockeford. Turn left onto Brandt Road. Cross Clements, take first driveway on left.
- HIGHWAY 12 ROAD CLOSURE \*\*\* CALTRANS has scheduled a road closure on State Route 12 at the Rio Vista Bridge to start 9:00 PM on Friday, November 15 through 4:00 AM on Monday, November 18, the weekend of these trials. For exhibitors using Highway 12 from Fairfield to Lodi, please check the Caltrans website www.dot.ca.gov for updates and alternate routes. Exhibitors driving via Sacramento or Stockton should not be affected.

# Parking and Grounds Information

- NO RV PARKING is allowed either during the day or overnight. RV's are not allowed on the grounds.
- NO SMOKING is allowed on the grounds.
- **PARKING IS LIMITED.** Please do not arrive more than one hour before your class. If your class is completed and the parking area is near capacity, please leave to give space to another entrant.
- VEHICLES MAY NOT BE LEFT IDLING in the parking area.
- PLEASE KEEP DOGS QUIET. If barking cannot be controlled, you will be asked to leave. Dogs must be kept on leash except when
  working in the ring. Note: Farm animals and cats are present on property. Air your dog in dog run or on gravel driveway. Do not air
  dogs on grass, plants, barn, equipment, side of building, or back of building.
- **CLEAN-UP.** Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.
- NO FOOD VENDORS will be available at this event. Exhibitors should plan to bring their own snacks and beverages. Fast food is available approximately 15 minutes away.
- WATER: Well water is available and safe to drink.

## Rally / Obedience Crating Rules and Trial Procedures

- RALLY EXHIBITORS Crating will be allowed in the building on Friday/Saturday only. Crating must be between the RED CONES! Spectators are allowed. SPACE IS LIMITED. A CLEAN towel or mat must be placed under your chair and crate to protect the matting.
- NO X-pens in the building. NO crate aggressive dogs in the building. A dog not entered in the trial is not allowed in the building. There is room to warm up outside on the patio.
- Rally exhibitors may leave their crates overnight in the building on Friday night. ALL chairs, crates, and setups must be removed immediately at the end of the Saturday Rally trial. The building will be emptied to be cleaned, equipment and furnishings moved out or rearranged, and two rings will be set up for the Sunday Obedience trial.
- <u>OBEDIENCE EXHIBITORS</u> NO INDOOR CRATING ALLOWED ON SUNDAY. SPECTATOR SEATING for viewing is allowed in the building. SPACE IS LIMITED. Chairs only will be allowed inside (bring your own chair). A CLEAN towel or mat must be placed under your chair to protect the matting.
- <u>ALL DAYS</u> Crating is allowed outside on the patio on the side of the building. Handlers may also work out of their car. Regardless
  of where handlers crate their dog, it is each handler's responsibility to know when it is their turn in the ring, and to be ready to go in
  the ring when it is their turn.
- NO CRATES OR CHAIRS MAY BE LEFT OUTSIDE OVERNIGHT.
- <u>CHECK-IN</u> will be in the building with the ring steward at the ring. There will be no door monitor, exhibitors and spectators will have access to the building during the trial.
