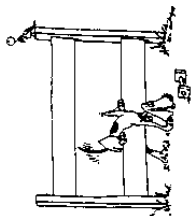

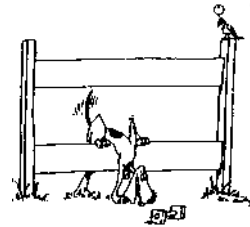

Transfer requests must be in writing to the Trial Secretary and will be accepted from the day after close of entries until 30 minutes before the trial judging begins.

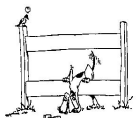

**EMAILED ENTRIES MUST INCLUDE THE AGREEMENT** printed alongside the Official AKC Entry Form. Print out the form (both parts together as it is shown), fill it out and sign it. Entries are not valid without your signature. Then either scan the entry to a PDF file, or take a picture with your smart phone. A "fillable" entry form for these trials is available at [www.going-2-dogs.com/attachments/SMSL\\_2024\\_Entry\\_Form\\_Fill.pdf](http://www.going-2-dogs.com/attachments/SMSL_2024_Entry_Form_Fill.pdf). Fill it out, sign it, and email to the Trial Secretary (page 2).

**PAY ENTRY FEES WITH PAYPAL:** To make your payment for emailed entries, go to [www.Going-2-Dogs.com](http://www.Going-2-Dogs.com), then to Upcoming Events. Click on "Pay Entry Fees with PayPal" and follow instructions. You do not have to be a PayPal member.

**THERE IS A SERVICE CHARGE OF \$5.00 PER DOG PER DAY** for paying with Paypal. Please add service charge to your payment amount. (Trouble paying? Be sure there is no "\$" or other special character in the amount field.)

Entry forms will not be processed until payment has been received, which must be on or before the closing date/time. Electronic payments prior to opening date/time are not acceptable.

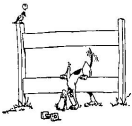

## Notice To Exhibitors

---

---

- **CONDITIONAL, UNSIGNED, INCOMPLETE, or telephoned entries will not be accepted.** Entries without fees cannot be accepted. See Page 6 for information on emailed entries.
- **ENTRIES NOT ON OFFICIAL AKC FORMS** or photocopies of entry forms without the Agreement and Instructions on the reverse side of the official AKC entry form are NOT ACCEPTABLE.
- **PLEASE TYPE OR PRINT CLEARLY** using black or blue ink.
- **OWNERS ARE RESPONSIBLE FOR ERRORS** on entry blanks, for entering the same dog twice, or for entering a dog in a class in which it is ineligible to compete, regardless of who makes such errors.
- **CHANGES**, additions, or corrections to entry forms must be received in writing prior to close of entries. Emailed changes are acceptable. Changes by telephone or text are NOT acceptable.
- **AN AKC RECORDING & EVENT SERVICE FEE** of \$3.50 will be required for each entry in any Licensed or Member Club Show, Obedience Trial or Tracking Test. **Rally:** An AKC Recording Fee of \$3.50 will be required for each Rally entry of a dog in a Licensed or Member Rally Trial. These fees are paid to the American Kennel Club and are included in the prices listed.
- **ENTRY FEES WILL NOT BE REFUNDED** in event of errors or cancellation of entries after the published closing date, nor in the event a dog is absent, disqualified, sick, lame, excused by the Veterinarian or Judge, or barred from competition by the Trial Committee.
- **THE WELL-BEING OF DOGS** and participants is of paramount importance. If, because of riots, civil disturbances, loss of site, fire, Act of God, act of a public enemy, strikes, extreme weather conditions (including but not limited to extreme heat, floods, snow storms, hurricanes, lightning, or earthquakes), or any other acts beyond the control of the management, it is impossible to open or complete the trial, no refunds of entry fee(s) will be made. **DO NOT LEAVE ANIMALS IN A HOT VEHICLE.**
- **BITCHES IN SEASON** are not permitted to compete. If a female is withdrawn from competition for coming into season and the Trial Secretary is notified no later than ½ hour prior to the start of the first class, then the club will refund the entry fee. **A processing fee of \$10.00 per entry will be retained.** A signed veterinarian's letter stating the bitch is in season must be provided as documentation with the request or within one week of the trial at the latest to receive a refund.
- **ELECTRONIC CONFIRMATION OF ENTRY & SCHEDULE OF JUDGING TIME** will be sent to the email address on the Official AKC entry form after the closing date. If the exhibitor wishes to have a **printed** schedule mailed, please request on the entry form. If an exhibitor has not received a copy of the schedule within seven days of the trial, the Trial Secretary should be contacted. (Please check your Spam folder before contacting the Secretary.)
- **DOGS NEED TO BE AT THE TRIAL** only at scheduled time of judging and may leave immediately after unless required for further judging.
- **CONSULT JUDGING PROGRAM** for time of judging. Exhibitors are responsible for having their dogs at ringside when it is their turn to be judged. Dogs not required for further judging may be excused after their class has been judged.
- **DOGS MUST BE KEPT ON LEASH** except when being judged in the ring.
- **THERE SHALL BE NO DRILLING** nor intensive or corrective training of dogs on the show grounds or premises.
- No provisions will be made for unentered dogs on the grounds.
- In the case of a tie for any prize, any dog that is not present for a run-off will forfeit its rights to the prize.
- **ALL AWARDS MUST BE CLAIMED THE DAY OF THE TRIAL. NONE WILL BE MAILED** or delivered. An exhibitor whose dog is eligible for a Special Award must be present or appoint a representative to accept the award
- **THE TRIAL-GIVING CLUB, THE TRIAL SECRETARY,** their agents or employees assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, spectators, or to any of their dogs or property, and further assume no responsibility for injury to any child not under the control of their parents or guardians.
